### Proposed New Irrigation Technician Course – Brad Ramsdale

- Proposing new course AEQ 2801 Reinke Certification for 1 credit hour
- Reinke has agreed to provide all of our irrigation technician student's access to this online training program regardless of whether or not the student is sponsored by Reinke.
- Course will be offered during the final 8-weeks of the 1-year irrigation technician program for on-campus students only.

- Course will provide an excellent culmination learning experience for the students and provide the student with an industry certification applicable to all Reinke dealers.
- Dan Stehlik will be the on campus instructor to provide guidance to students and answer questions

## Human Relations Replacement – Eric Reed

- Would like to replace the Human Relations course with a "Leadership in Agriculture course
- This would not be a psychology course and would not require an instructor with 18 graduate hours in this area to teach it.
- > Would remove the hours from the general education program
- Possibly the leadership class will fit the general education transfer program
- Could possibly make it a transfer leadership course
- Discussion
- > The course can be tied into a civic engagement outcome
- We could keep Human Relations course and have someone with a masters in psychology teach it online with Tee helping with the class on campus
- ➤ It was suggested that we add this course and leave the Human Relations course in the catalog
- It was suggested that we incorporate a policy for students who transfer to NCTA that already have a Bachelors degree that they automatically meet all general education requirements.
- Will bring back to the next meeting for approval

## Payments for TA's - Eric Reed

- For instructors to teach Chemistry online they must have a minimum of 18 graduate hours in Chemistry and a minimum of 3 years teaching Chemistry on-line
- > Eric has hired an instructor to teach Chemistry
- The class will be developed as if it could be taken 100% online. The students will be required to meet 3-4 times a week as they do now.
- > The labs will be completed here on campus
- Eric would like to hire Dan Widick to oversee the class and the on campus labs
- > Some online Chemistry courses have kits or software to do labs off campus
